

Information on the Right of Withdrawal for Consumers

Right of withdrawal for consumers

You have the right to withdraw from this contract within fourteen days without indicating any reasons; this fourteen-day withdrawal period shall commence at the time of contract conclusion.

For exercising your right to withdrawal, you are obligated to inform us (AENGEVELT Immobilien GmbH & Co. KG, Kennedydamm 55, 40476 Düsseldorf, phone number: +49 (0)211/83910, fax: +49 (0)211/8391255, e-mail: kontakt@aengevelt.com) through an unequivocal declaration (such as by registered letter, by fax or by e-mail) about your intention to withdraw from the contract.

You may also use the template withdrawal form provided for this purpose in the following, but you are not obligated to do so.

For keeping the withdrawal deadline, it shall be sufficient to post your declaration as to the intention to exercise your right to withdrawal prior to the end of the withdrawal period.

Consequences of the Withdrawal

In the case where you decide to withdraw from the contract, we are obligated to reimburse to you any payments which we received from you, including any delivery costs (apart from additional costs resulting from you having selected any other type of delivery deviating from the cheapest standard type of delivery offered by us). We shall do so immediately and in no case later than fourteen days after the day of the receipt of the notification as to your intention of withdrawing from the contract. For these reimbursements, we are going to apply the same payment means which you made use of for the original transaction, unless we expressly agreed upon something deviating. In no case will we charge any fees relating to such reimbursements.

In the case where you requested that any services be rendered during the withdrawal period, you will be obligated to pay a reasonable amount of money to use which corresponds to the percentage of the services which we have already provided by the time of your notification of your intention to exercise your right to withdraw from the contract compared to the full extent of the services provided for under the respective contract.

Execution of the Contract

Any requested documents will be provided only after the (fourteen-day) period of withdrawal terminated.
